FHIPO INFORMS THE ISSUANCE OF CERTIFICADOS BURSÁTILES FIDUCIARIOS UNDER TICKER SYMBOLS CDVITOT15U AND CDVITOT15-2U, WHICH AMOUNTED TO \$4,232 MILLION PESOS

Mexico City, September 8th, 2015 – Fideicomiso Hipotecario (BMV: FHIPO) (“FHipo”), the first Mexican real estate investment trust specialized in the acquisition, origination, co-participation, management and operation of mortgage portfolios, announces today, together with the *Instituto del Fondo Nacional de la Vivienda para los Trabajadores* or “Infonavit”, the successful issuance (mortgage securitization) of Preferred *Certificados Bursátiles Fiduciarios* (“CBFs”) with ticker symbol CDVITOT15U and Subordinate CBFs with ticker symbol CDVITOT15-2U, issued under the Trust 80739 created by Infonavit and FHipo, as Trustors, and Nacional Financiera as Trustee, to which both assigned all rights of certain loans originated under the Infonavit Total Program and currently co-participated by FHipo. The total issuance amounts to \$4,232.3 million pesos, with an interest rate of 2.80% in UDIS for the senior tranche and 4.12% in UDIS for the subordinated tranche. The proceeds of the issuance corresponding to FHipo will be of \$2,387.9 million pesos for the senior tranche, and \$214.2 million pesos for the subordinated tranche, without considering issuance costs.

The underwriters who participated in the issuance were; HSBC Casa de Bolsa, S.A. de C.V., Grupo Financiero HSBC, Casa de Bolsa Banorte Ixe, S.A. de C.V., Grupo Financiero Banorte, Casa de Bolsa BBVA Bancomer, S.A. de C.V., Grupo Financiero BBVA Bancomer and Interacciones Casa de Bolsa, S.A. de C.V., Grupo Financiero Interacciones.
